THE PRACTITIONER PLUS THE ART IS WHAT IS APPROVED BY THE OREGON COUNTRY FAIR! The practitioner must be at the Fair, all three days, to sell the approved esoteric art.

Provide a description of your art. Our Craft Inventory database is built on Product, Technique, and Material. So a Reiki practitioner might be described as having a Product = healing, Technique = Reiki, Material = people & hands. We try to write the descriptive listings so that people wishing to find you at the Fair will be able to.

Please also provide a thorough and convincing narrative explaining your experience with and your commitment to this art. Because we have applicants from long distances, we aren't able to do face-to-face interviews; we might need to make our choices based on the paperwork you send us. We will call or e-mail you with news and results as soon as we can (some time in May).

Being successfully juried is NOT A GUARANTEE of space to sell at the Fair. **If your art is approved, it is your responsibility to find a booth representative in an existing booth at the Fair to agree to take you into their booth** — though we will do what we can to help. We encourage you to network with other booth people.
